Delisting Determination, The Nasdaq Stock Market, LLC, August 11, 2020, Global Eagle Entertainment Inc. The Nasdaq Stock Market, LLC (the Exchange) has determined to remove from listing the common stock of Global Eagle Entertainment Inc. (the Company), effective at the opening of the trading session on August 21, 2020.
