The Starting Value for the ARNs was defined in the final term sheet (the "Final Term Sheet"), dated September 27, 2012 and filed with the Securities and Exchange Commission (the "SEC") on October 1, 2012. The Starting Value was defined as the lowest closing level of the Market Measure on any Market Measure Business Day during the Starting Value Determination Period on which a Market Disruption Event has not occurred. The closing level of the Market Measure on September 27, 2012 was 667.30.

The Starting Value Determination Period has expired. The lowest closing level of the Market Measure on any Market Measure Business Day during the Starting Value Determination Period on which a Market Disruption Event did not occur was 645.76, which is less than 667.30.

Therefore, the Starting Value for the ARNs is 645.76.
