

## Terms of the Notes

The Contingent Income Issuer Callable Yield Notes Linked to the Least Performing of the Nasdaq-100® Index, the Russell 2000® Index and the S&P 500® Index (the "Notes") provide a monthly Contingent Coupon Payment of \$8.667 on the applicable Contingent Payment Date if, on any monthly Observation Date, the Observation Value of each Underlying is greater than or equal to its Coupon Barrier. Beginning on January 22, 2025, and on each monthly Call Date thereafter, we have the right to redeem all, but not less than all, of the Notes at 100% of the principal amount, together with the relevant Contingent Coupon Payment. No further amounts will be payable following an Optional Early Redemption. If the Notes are not called, at maturity you will receive the Redemption Amount, calculated as described under "Redemption Amount Determination".

<b>Coupon Barrier:</b>	For each Underlying, 70% of its Starting Value.
<b>Call Dates*:</b>	Monthly. Please see the Preliminary Pricing Supplement for further details.
<b>Threshold Value:</b>	For each Underlying, 70% of its Starting Value.
<b>Contingent Coupon Payment*:</b>	If, on any monthly Observation Date, the Observation Value of each Underlying is greater than or equal to its Coupon Barrier, we will pay a Contingent Coupon Payment of \$8.667 per \$1,000 in principal amount of Notes (equal to a rate of 0.8667% per month or 10.40% per annum) on the applicable Contingent Payment Date (including the Maturity Date).
<b>Optional Early Redemption:</b>	On any Call Date, we have the right to redeem all (but not less than all) of the Notes at the Early Redemption Amount. No further amounts will be payable following an Optional Early Redemption. We will give notice to the trustee at least five business days but not more than 60 calendar days before the applicable Call Date.
<b>Early Redemption Amount:</b>	For each \$1,000 principal amount of Notes, \$1,000 plus the applicable Contingent Coupon Payment.
<b>Initial Estimated Value Range:</b>	\$941.70 and \$981.70 per Note.
<b>Underwriting Discount*:</b>	\$1.5 (0.15% of the public offering price) per Note.
