Summary of Terms

Issuer and Guarantor:	BofA Finance LLC (“BofA Finance” or “Issuer”) and Bank of America Corporation (“BAC” or “Guarantor”)
Underlying Stocks:	The Class A common stock of Meta Platforms, Inc., the common stock of Amazon.com, Inc. and the class A common stock of Alphabet Inc.
Pricing Date*:	March 15, 2024
Issue Date*:	March 20, 2024
Denominations:	\$1,000 and any integral multiple of \$1,000. References in the pricing supplement to a “Security” are to a Security with a principal amount of \$1,000.
Contingent Coupon Payments:	On each Contingent Coupon Payment Date, you will receive a Contingent Coupon Payment at a per annum rate equal to the Contingent Coupon Rate if, <b>and only if</b> , the stock closing price of the Lowest Performing Underlying Stock on the related Calculation Day is greater than or equal to its Coupon Barrier. Each Contingent Coupon Payment, if any, will be calculated per Security as follows: $(\$1,000 \times \text{Contingent Coupon Rate}) / 4$
Contingent Coupon Payment Dates:	Quarterly, on the third business day following each Calculation Day; provided that the Contingent Coupon Payment Date with respect to the Final Calculation Day will be the Maturity Date.
Contingent Coupon Rate:	At least 17.55% per annum, to be determined on the pricing date
Automatic Call:	If the stock closing price of the Lowest Performing Underlying Stock on any of the Calculation Days from September 2024 to December 2026, inclusive, is greater than or equal to its Starting Price, the Securities will be automatically called, and on the related Call Settlement Date you will be entitled to receive a cash payment per Security equal to the principal amount per Security plus a final Contingent Coupon Payment.
Calculation Days*:	Quarterly, on the 15th day of each March, June, September and December, commencing June 2024 and ending December 2026, and March 15, 2027 (the “Final Calculation Day”).
Call Settlement Date:	Three business days after the applicable Calculation Day
Maturity Payment Amount (per Security):	<ul style="list-style-type: none"> <li>if the Ending Price of the Lowest Performing Underlying Stock on the Final Calculation Day is greater than or equal to its Threshold Price: \$1,000; or</li> <li>if the Ending Price of the Lowest Performing Underlying Stock on the Final Calculation Day is less than its Threshold Price: <math>\\$1,000 \times \text{Performance Factor of the Lowest Performing Underlying Stock on the Final Calculation Day}</math></li> </ul>
Maturity Date*:	March 18, 2027
Lowest Performing Underlying Stock:	For any Calculation Day, the Lowest Performing Underlying Stock will be the Underlying Stock with the lowest Performance Factor on that Calculation Day.
Performance Factor:	With respect to an Underlying Stock on any Calculation Day, its stock closing price on such Calculation Day divided by its Starting Price (expressed as a percentage).
Starting Price:	For each Underlying Stock, its stock closing price on the pricing date
Ending Price:	For each Underlying Stock, its stock closing price on the Final Calculation Day
Coupon Barrier:	For each Underlying Stock, 70% of its Starting Price
Threshold Price:	For each Underlying Stock, 70% of its Starting Price

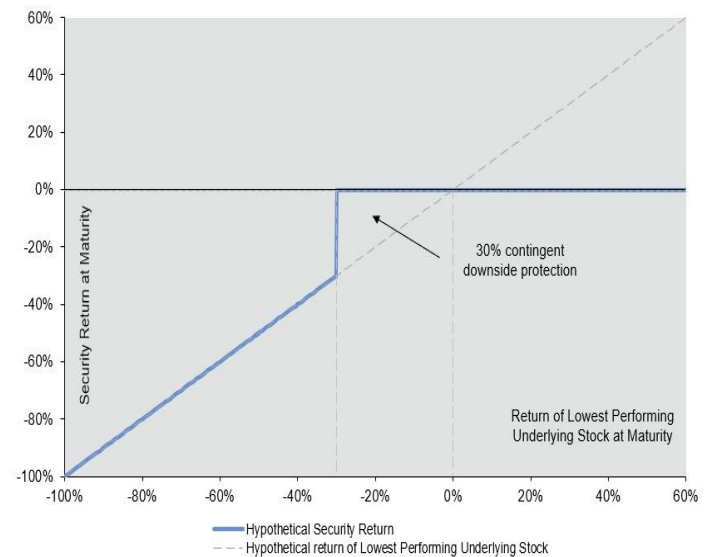

Calculation Agent:	BofA Securities, Inc. (“BofAS”), an affiliate of BofA Finance
Underwriting Discount**:	Up to 2.325%; dealers, including those using the trade name Wells Fargo Advisors (WFA), may receive a selling concession of 1.75% and WFA may receive a distribution expense fee of 0.075%.
CUSIP:	09711B6B7
Material Tax Consequences:	See the preliminary pricing supplement.

If the Securities are not automatically called prior to maturity and the Ending Price of the Lowest Performing Underlying Stock on the Final Calculation Day is less than its Threshold Price, you will lose more than 30%, and possibly all, of the principal amount of your Securities at maturity.

Any return on the Securities will be limited to the sum of your Contingent Coupon Payments, if any. You will not participate in any appreciation of any Underlying Stock, but you will have full downside exposure to decreases in the value of the Lowest Performing Underlying Stock on the Final Calculation Day if the Ending Price of that Underlying Stock is less than its Threshold Price.

The initial estimated value of the Securities as of the pricing date is expected to be between \$910.00 and \$960.00 per Security, which is less than the public offering price. The actual value of your Securities at any time will reflect many factors and cannot be predicted with accuracy.
