

<b>Issuer</b>	Bank of America Corporation ("BAC")
<b>Principal Amount</b>	\$10.00 per unit
<b>Term</b>	Approximately two years, if not called
<b>Market Measure</b>	PHLX Housing Sector <sup>SM</sup> Index (Bloomberg symbol: "HGX")
<b>Automatic Call</b>	The notes will be called automatically on the Observation Date if the closing level of the Market Measure is equal to or greater than the Call Level

<b>Observation Date</b>	Approximately one year from the pricing date
