

Denominations:	\$1,000 and any integral multiple of \$1,000.
Automatic Call:	If the closing value of the Lowest Performing Underlying on the Call Date is greater than or equal to its Starting Value, the Securities will be automatically called for the principal amount plus the Call Premium.
Call Date*:	May 13, 2026
Call Premium:	At least 36.00% of the principal amount
Lowest Performing Underlying:	The Lowest Performing Underlying is the Underlying with the lowest Performance Factor on the Call Date or the Final Calculation Day, as applicable.
